1.1 Running and/or making excessive noise in the corridors.	1.1 Yellow card and verbal warning.	1. Children given an explanation of inappropriate behaviour and reminded of desired behaviour.
1.2 Refusals to follow requests.	1.2 Yellow card.	2. Stickers, praise and dojo awards for positive actions on behaviour monitoring.
1.3 Being improperly dressed (students who fail to abide by the school uniform policies may not be excluded or otherwise barred from attending school but may lose extra-curricular privileges).	1.3 1 <sup>st</sup> – uniform provided. 2 <sup>nd</sup> – a letter home to parents and call home for appropriate clothing.	3. Class teachers share a pupil’s targets with the class and gain their agreement in achieving the targets.
1.4 Displaying any behaviour that is disruptive to the orderly process of the classroom such as shouting out, making noises, flicking or throwing things.	1.4 <i>The child will be subject to actions through the school behaviour system.*</i>	4. Clear targets set and explained and agreed with parents.
1.5 Unauthorised use within the classroom of personal possessions including games and mobile phones.	1.5 They are removed and placed in the safe for collection at the end of the day, any subsequent incidences items will need to be collected by parents.	5. Child will attend a nurture support, anger management or other designated group within school.
1.6 Failing to attend class without a valid excuse.	1.6 <i>The child will be subject to actions through the school behaviour system.*</i>	6. Child may be required to attend school on a reduced timetable to aid the reintegration into school.
1.7 Persistent lateness to school or class.	1.7 Referral made to the Education Welfare Service.	

### Behaviour Policy – Lesson Time

1. Explain expected behaviour.
2. Verbal warning.
3. Yellow card - loose play time (detention).
4. Red card – loose whole play time, fill in ‘Put it right sheet’ and inform parents with a letter home- copy put it right sheet in with letter.
5. 2 red cards – miss whole lunch, 2 red cards in a lesson go to a buddy class for reminder of am/pm session and inform parents with a letter home.

Use, possession, sale or delivery of alcohol, illegal drugs, controlled substances, 'look-alikes' of such substances or contraband or use of any other substance for the purpose of intoxication.	Permanent exclusion	Social Care and Health and police contacted.

### **Lunchtime behaviour consequences**

Staff outside can give a verbal warning for low level behaviour and explain the desired behaviour.

For any rough boisterous acts please follow the steps below;

1. Children to be sent into the "Put it Right Room" to explain the issue.
2. Yellow or Red card issued, child will then be sent into the 'put it right room' for the following amounts of time or longer if deemed necessary. 15 mins for Yellow or 30 mins for Red- longer if deemed necessary depending on what was happening, and pupils attitude.
3. Record made on SPTO system.
4. CT informed and a letter home for EACH Red offense.
5. Repeated problems at lunchtime- lunchtime exclusion.
